

Pope: Millions losing their religion and declaring God is dead

Modern culture is so devoid of faith that some people are declaring God "dead" and entire nations are losing their identity, Pope Benedict XVI warned yesterday.

The 81-year-old pontiff said that God was being pushed out of people's lives under the "harmful and destructive influence" of today's society.

His comments, made during a Mass at the start of a month-long synod of Roman Catholic bishops from around the world, come amid growing concern about the decline in church attendance and interest in religion in many Western nations.

Pope Benedict is particularly worried about a growing indifference to religion in Europe.

In recent decades, the Catholic Church's influence has seen a decline in developed countries, although it is growing in the Third World.

Both the Church of Scotland and Scottish Catholic Church have seen a drop in worshippers in recent years - the Church Scotland has numbers fall nearly 60 per cent since 1960, and between 1994 and 2003, Mass attendances fell from 250,000 to 194,728. Farlier this year the Vatican also reported a the fall dramatic in number of Roman Catholic monks and nuns.

Ronnie Convery, spokesman for the Scottish Catholic Church, said Pope Benedict's comments reflected the concerns religious leaders had been aware of for some time.

"What we are seeing is that our culture has changed, subtly but significantly," Mr Convery said. "Many people today, even though they wouldn't declare themselves atheist, behave as though God doesn't exist.

"One of the main challenges of the Catholic Church is to remind people of their Christian roots and the important role that the Church has played in the shaping of our culture."

FFRF Sues over National Day of Prayer

MADISON, Wis. (AP) --The nation's largest group of atheists and agnostics is suing President Bush, the governor of Wisconsin and other officials over the federal law designating a National Day of Prayer.

Freedom From Religion Foundation sued Friday in U.S. district arguing that the court, president's mandated proclamations calling on Americans to pray violates a constitutional ban on government officials endorsing religion.

The day of prayer, held each year on the first Thursday of May, creates a "hostile environment for nonbelievers, who are made to feel as if they are political outsiders," the lawsuit said.

The national proclamation issued this year asked God's blessings on our country and called for Americans to observe the day with appropriate programs, ceremonies and activities.

Doyle is named in the suit because he is one of 50 governors who issued proclamations calling for the prayer day. The foundation is based in Madison.

Shirley Dobson, chairwoman of the National Day of Prayer Task Force, and White House press secretary Dana Perino also are named.

The foundation has filed numerous lawsuits in recent years, including one rejected by the U.S.

Halloween: The Chri

For the Christian today, our diverse American culture poses many real challenges in determining what he or she should and should not partake in. There is such a blending of belief systems and melding of cultural practices that for those who try to follow closely to the teachings of Jesus Christ, it can be a daunting task riddled with humanly perceived "gray areas." In keeping with the season, I would like to address the Christian's response to the celebration of Halloween.

I do not want to go into an exhaustive background, but Halloween began with ancient Druid beliefs that this time of year the souls of the deceased could and sometimes did come back to pester and possess the bodies of the living. Therefore, many of the customs that are still performed today have roots in actual Druid ritual. Carving Jack 'o' Lanterns and dressing up in frightening costumes was an attempt to scare away evil spirits. Building giant bonfires (derived from "bone-fires") was intended to do the same and also eradicate anyone who was believed to be possessed by an evil Furthermore, today the "holiday" is celebrated by neo-Pagans, Wiccans, and even Satanists somewhat of a high holiday.

So, if this is the case, what is a Christian to do? What's so terrible about dressing up as a princess or a pumpkin and going door to door begging for candy? What possible harm can come from carving a pumpkin or bobbing for apples? would venture to say that these things in and of themselves are not wrong and definitely not the point. The bottom line is this: Halloween today in our culture, no matter how any individual celebrates it, glorifies death, evil, and fear. As a Christian, we know that Jesus came to overcome the power of death, defeat evil, and eliminate fear. then would a Christian partake in an event that, no matter what their celebration includes, glorifies the very things Christ came to abolish?

argue that our

Christmas customs for celebration have pagan roots and therefore would be wrong to partake of according to my argument, then you are right on the first part at Many Christmas customs do indeed come directly from pagan practices—the lighting of a tree and the yule log, just to name two. However, I would argue that you are incorrect on the second part of your statement. What, today, does Christmas stand for? Does it not still mark the celebration of the birth of the Savior of the world, Jesus Christ? You would be correct in noticing the need to eradicate the overemphasis disgusting commercialism and blatant the substitution of the true meaning of

Therefore, my analogy goes like this: Celebrating Halloween in the sense of celebrating the harvest and honoring the Saints that have gone before us would in theory be acceptable as a Christian, just as celebrating Christmas as the commemoration of the birth of Christ is acceptable. (The Catholic Church unsuccessfully tried to replace pagan meanings of Halloween, thus "All Hallow's Eve," which morphed into "Halloween" with "hallow" having the meaning of one who is hallowed or holy. Think, "Our Father, who art in

heaven, hallowed be thy Name...") Both celebrations go wrong when the pagan is celebrated over the Christian. In the case of Halloween, glorifying death, evil, and fear is akin to placing the myth of Santa Claus in place of the real Jesus Christ while prioritizing the giving and receiving of gifts over glorifying the Giver of the Greatest Gift of all at Christmas time. I believe it is simply summed up in the following verse: "Do not quench the Spirit. Do not despise prophecies, but test everything; hold fast what is good. Abstain from every form of evil" (1 The 5:19-22, ESV)

As a Christian we have the responsibility to ensure we are thinking through everything we do in general, and specifically in this case with celebrations to make sure we are glorifying God, holding to only that which is good, and keeping far away from anything that is associated with evil. I cannot personally get around the fact that Halloween glorifies death, evil, and fear. It should be obvious that this is the clear meaning behind this day. Halloween movies more often than not feature brutal massacres, witchcraft as fun and acceptable, and glorification of the demonic side of the very real spiritual realm. The fiction that has been created about ghosts, zombies, and the like have their roots in reality and can only be demons as described in the Bible. There is a spiritual realm that features very good and very bad spirits. We should not, especially as Christians, make light of this and consequently behave as if the evil is "cute" or "harmless" or anything else other than a terrible offense to God and contrary to everything He is.

We suffer from an epidemic of Christians that behave exactly the same, or at least nearly the same as their non-Christian counterparts without regard for taking a stand for what is pure and holy. We need to not be afraid of looking weird or irrelevant when we speak out against or abstain from celebrating overtly pagan and evil "holidays" such as Halloween. It is time we did as the writer in Hebrews describes when he writes: "...Let us also lay aside every weight, and sin

which clings so closely, and let us run with endurance the race that is set before us..." (Heb 12:1, ESV)

I challenge every Christian who reads this article to examine the Word of God, specifically, and carefully consider what I present to you even if you initially disagree with my stance. I believe that any Christian absolutely must treat any and all matters of life, not exclusively the "hot button" issues like the celebration of Halloween, in this manner. We cannot afford to slog through life accepting or rejecting doctrine, lists of right and wrong, and in this case celebrations based on our culture at large, what someone we care about or respect said, or whatever happens to fit our personal preferences. There is absolute truth out there, and we all must strive to find it and understand it to the best of our imperfect human ability and live our lives accordingly. Ultimately, we will be held accountable for our actions and what we supported or fought against in the end.

I do not say all this to suggest that a Christian cannot Halloween and still be "right with There are godly men and women I know and respect and whose salvation I would not question who advocate at least portions of current American Halloween customs. I do not have a problem with disagreeing with them and personally choosing to abstain, but I only continue to respect their opinion if they have demonstrated that they are convinced that they are doing what is pure and holy to the best of their ability. I do, however, strongly infer that a true Christian will examine their hearts and motivations

'Religulous' filmed at Catholic parish under false pretenses?

Newark, Oct 19, 2008 / 06:19 (CNA).pm spokesman the for Archdiocese of Newark has responded to reports that comedian Bill Maher filmed part of his antireligion documentary "Religulous" at a parish in the archdiocese.

Maher set part of the film at Our Lady of Mercy in Park Ridge, New Jersey. The relevant scenes show his sister and his Jewish mother, who explains why his Catholic father stopped going to church.

Jim Goodness, an archdiocesan spokesman, told The Record that he turned down two requests use the church property, one from Maher's production company and one from the parish.

"This certainly would not be the kind of project we would have given a green light to," he said.

Goodness explained that the archdiocese doesn't allow church property to be used for commercial purposes.

"And I personally didn't trust Mr. Maher," Goodness told The Record.

"Obviously, our policies were not followed."

According to the Associated Press, Goodness said the parish pastor Father Charles Grandstrand was aware of the policy.

However, according to Goodness, filmmakers told Father Grandstrand that Maher wanted to film his mother there because the Church was such a big part of her life.

Maher has admitted that he didn't tell people his movie would take its name from a combination the words "religion" and "ridiculous." Instead, he told them the film be named bluow Spiritual Journey."

On Thursday the Star-Ledger reported that Father Grandstrand claims Goodness told the church to reject the production company's request to film but told administrative parish's it assistant would alright to let Maher talk to his mother in the church.

Goodness responded by saying he remembered the events differently and had told the priest not to let the company film anything inside the church.

Bishop's column on abortion prompts IRS review

Paterson, N.J., Oct 23, 2008 / 06:16 pm (CNA).-A New Jersey bishop's newspaper column which criticized Sen. Barack Obama's support for proabortion legislation has prompted the activist group Americans United for Separation of Church and State to request an Internal Revenue Service investigation. The group alleges that Bishop Arthur Serratelli violated regulations forbidding taxexempt organizations from tying political issues to the candidates who support them.

Bishop Serratelli's In October 23rd column, A" Politician's titled Promise: No Right to Life! Freedom!", he examined the status of abortion law in America today, noting that most Americans now favor "some kind of a ban on abortion" and that the number of abortions is in decline.

"There is truly a deep sensitivity to life in the soul of America," he continued, claiming the proposed Freedom of Choice Act (FOCA) would "mortally wound this sensitivity."

According to the bishop, the proposed federal **FOCA** bill would remove the rights of medical personnel and hospitals which have moral objections to performing abortions.

"Gone the freedom of conscience so essential for a civil society!" Bishop Serratelli predicted.

Further, health regulations for safety abortion clinics would be removed, as would waiting periods and parental consent laws, Serratelli stated. Under FOCA, he said, taxpayers could be forced to fund abortions and babies who survive abortions could even be left to die.

The bishop then referred to Sen. Barack Obama's support for FOCA. He did not mention Obama by name, instead calling him the "present democratic candidate."

The bishop compared Obama's promise to support FOCA to King Herod's promise to Herodias, which resulted in the execution of John the Baptist.

"In a speech before the Planned Parenthood Action Fund last year," Bishop Serratelli wrote, "he made the promise that the first thing he would do as President would be to sign the Freedom of Choice Act. What a choice for a new President!"

"Today we live in a democracy," the bishop continued. "We choose our leaders who make our laws. Every vote counts. Today, either we choose to respect and protect life, especially the life of the child in the womb of the mother or we sanction the loss of our most basic freedoms. At this point, we are still free to choose!"

Supreme Court last year that attacked President Bush's faith-based initiative.

The White House and Doyle spokesman Lee Sensenbrenner had no comment on the lawsuit. A message seeking comment from the task force was not returned Friday.

Wednesday press release, claimed that Bishop Serratelli's column "clearly sends a message that Ohama's opposes candidacy."

Rev. Barry W. Lynn, executive director of the group, sent a letter to the Wednesday on arguing that federal tax law requires tax-exempt groups to "avoid any issue advocacy that functions as political intervention."

"Bishop Serratelli essentially telling congregants that they have to vote against Obama or they'll lose freedoms, said according to the Lvnn, press release. "He went right up to the line and then leaped over it. The IRS should act."

According USA Today, Lynn also claimed it is "impossible to interpret this passage as anything but a command to vote against present Democratic candidate' because of his promise to sign a certain piece of legislation disfavored by Catholic Church's hierarchy."

Α spokesman for Americans United told USA Today that the group has about 90 similar claims with the IRS since 1996. Of these, four have previously accused Catholic bishops or dioceses "electioneering."

Earlier this year, the group asked the IRS to investigate Bishop Providence Thomas Tobin for criticizing former New York City Mayor Rudy Giuliani. who was Republican presidential candidate at the time.

Diocese of Patterson issued а statement commenting Bishop that Serratelli's column was focused on proposed abortion legislation, not the upcoming presidential election.

"It's absolutely, positively misleading say that the bishop urged Catholics not to vote for Sen. Obama," the diocese
